## ANNOUNCEMENT

### Visa exemption agreement on between Myanmar and Singapore (9th June 2016)

The Government of the Republic of the Union of Myanmar and the Government of the Republic of Singapore signed a visa exemption agreement for citizens of both countries who hold ordinary passports and travel by air. The agreement was signed and exchanged by H.E. U Kyaw Tin, Minister for Foreign Affairs of Myanmar and H.E. Mr. Robert Chua, Ambassador of Singapore, in Nay Pyi Taw, Myanmar on 7 June 2016. The exemption of visa will become effective on 1 December 2016.

According to the Agreement, citizens of either countries who one holding ordinary passports with at least six (6) months validity from the date of entry shall be exempted from any visa requirements for entry into, exit from and transit through the territory of the other country through international airports, and shall be entitled to stay in the territory of the other country for a period not exceeding thirty (30) days from the date of entry.

Myanmar had signed the similar agreements with Brunei Darussalam, Cambodia, Laos, the Philippines, Thailand and Viet Nam in accordance with the 2006 ASEAN Framework Agreement on Visa Exemption.
